# **OSHA Regulation**

#### Not an Exit 1910.37(b)(5)

Any door, passage, or stairway that is not an exit or a way to get to an exit, but looks as though it could be an exit must be marked with a sign reading "NOT AN EXIT," or must be identified by a sign telling what it is, such as "to basement," "storeroom," "linen closet," or whatever it may be.

#### Evacuation Route 1910.38(a)(2), 1910.120(1) (2)(vi) (Informational marking)

Elements of an emergency response plan. The employer shall develop an emergency response plan for emergencies which shall address, as minimum, the following:...(vi) Evacuation routes and procedures.

#### Exit 1910.37(b)(4)


If the direction of travel to the exit or exit discharge is not immediately apparent, signs must be posted along the exit access indicating the direction of travel to the nearest exit and exit discharge. Additionally, the line-of-sight to an exit sign must clearly be visible at all times.

## EXIT 29 CFR 1910.37 (b)(7)

Each exit sign must have the word "Exit" in plainly legible letters not less than 6" (15.2 cm) high, with the principal strokes of the letters in the word "Exit" not less than 3/4" (1.9 cm) wide.





